3. The Bidders Must Download the bidding document through e-GP II Portal of PPMO websites www.bolpatra.gov.np/e-GP. on or before 2076/12/18 (31st March 2020) for **tender**.
4. Bids must be submitted electronically through e-GP II of PPMO website www.bolpatra.gov.np/egp. The bidders shall pay non refundable fee as specified above in Ministry of Industry, Tourism, Forest and Environment, Ministry Code 3070013011, Account No. 1000200010000, Revenue Head 14229, Bank Name: -Rastriya Banijya Bank, Biratnagar and submit scanned electronic copy of the bank receipt along with the all electronic bid files.
5. The bid must be submitted on or before 12:00 hour noon of 2076/12/18 (31st March 2020) for **tender**. The accepted e-bid shall be open in the presence of the bidders representatives who choose to attend at 14:00 hours on the last date of bid submission. Non-attendance of any or all the Bidders representatives shall not hinder the opening of the bids. Bids must be accompanied by bid security amount as stated in above table either in the form of bank voucher confirming cash deposit in Ministry of Industry, Tourism, Forest and Environment. **Office Code:** - 3070013011, **Account no** - Pradesh kha -2; 2120502000000, Province Treasury Controller Office Province No.1 "**Dharauti Khata**" at Rastriya Banijya Bank, Biratnagar or a bid security issued by a commercial bank approved by (Nepal Rastriya Banijya Bank) validity for minimum 120 days for **tender** as prescribed format counting from the date of bid opening.
