Ministry of Forests, Environment and Soil Conservation, Province no. 1 invites Open Competition Bidding from Eligible Bidders for the **Supply and Delivery of Electric Van** for Ministry under National Competitive Bidding Procedure. Please refer to the Complete set of bidding documents through website: www.bolpatra.gov.np for detail information.
2. The Bidders must download the Bidding Document through e-GP Portal of PPMO website: www.bolpatra.gov.np/egp.
3. Bids must be submitted electronically through e-GP of PPMO website: www.bolpatra.gov.np/egp. The Bidders shall pay on non-refundable fee as specified above in Ministry of Forests, Environment and Soil Conservation, Province 1 Ministry Code 3290013011, Account No. 1000100201010001, Revenue Head 14229, Bank Name:- Rastriya Banijya Bank, Birtnagar and submit scanned electronic copy of the bank receipt along with all electronic bid files.
4. The bid must be submitted on or before 12:00 hour noon of **2079/10/21 (4th February, 2023)** for tender. The accepted e-bid shall be open in the presence of the bidders representatives who choose to attend at 13:00 hours on the last date of bid submission. Non-attendance of any or all the Bidders representatives shall not hinder the opening of the bids.
5. Bid must be valid for a period of 90 days after bid opening and must be accompanied by a bid security of scanned copy of the bid security in pdf format, amounting to a minimum of 135000 NRs which shall be valid for 30 days beyond the validity period of the bid.
6. Pre-bid meeting shall be held at Ministry of Forests, Environment and Soil Conservation, Biratnagar at 13:00 Hours on 29th January, 2023.
7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. Bids should comply in all respects with the Instructions to Bidder included in the Bid Document. Non-compliance with this instruction shall result in disqualification.
9. The Employer reserves the right to accept or reject, wholly or partly, any or all the bids without assining reasons, whatsoever.
10. Matters not covered by this notice shall be in accordance with Public Procurement Act, 2063 and Public Procurement Regulation, 2064 and other prevailing rules and regulations.
